Purpose and Scope

1. To promote the spiritual growth and development of the children of PCF through specific Sunday school activities.
2. To provide learning opportunities for all children in order to develop their social, emotional, intellectual and spiritual wellbeing. To promote equal opportunities for all children and promote an exciting and safe environment for children to learn in.
3. To work closely with the Pastors, Sunday School Leader and Sunday School Teachers to support the full range of activities within the ministry. You will therefore, be responsible for establishing positive working relationships with teachers and colleagues at all levels.
4. To be responsible for preparing, studying, and teaching lessons found in the agreed Teacher's manual or that which has been developed with and under the direction of the Pastors.
5. To be responsible for all aspects of review and validation of specified in-house programmes, providing support for young people and teachers and developing and sustaining an effective administration procedure.
6. To ensure all safeguarding procedures are adhered to in line with the PCF Child Protection policy

Duties and Responsibilities

1. To work with the Sunday School Leader to feed into the develop strategies in order to implement the vision of the PCF Church and PCF young people's department.
2. In conjunction with the Sunday School Leader develop curriculum for assigned Sunday Schools group, inclusive of the sourcing/development of literature, materials and assessment framework. And to disseminate this information to the Sunday School Teachers.
3. To oversee and supervise the work of Sunday School Teachers and Teachers on a Sunday Morning (inclusive of termly individual/team supervision)
4. To lead behaviour management and liaise with parents, carers and professionals
5. To be responsible for the maintenance and management of an effective child registration system

6. To participate in, and implement the outcomes of various developmental training
7. To actively promote, manage and maintain health and safety, equal opportunities, data protection and safe guarding practices and procedures
8. To plan for and maintain provisions for children with special educational needs
9. To conduct termly planning, monitoring, evaluating and reporting for assigned group
10. To undertake other reasonable tasks as required
11. To endorse and support the PCF Statement of Faith and its beliefs.

Person Specification

- At least 18 years of age and have the ability and demonstrable desire to teach
- A member of the PCF fellowship in good standing or be willing to join the church.
- Reliable and a committed to good time keeping

EXPERIENCE:

- Substantial experience in a faith based environment and have a personal relationship with Jesus Christ
- Previous experience of working with children, preferably in a similar context

QUALIFICATIONS AND SKILLS:

- The ability to work under pressure, independently and as part of a team
- Sound IT skills
- The ability to learn quickly, apply new knowledge, multi-task and maintain focus on key issues
- A willingness to develop and keen to learn new skill
- The ability to present complex information clearly and concisely.
- Ability to organise and prioritise work demands to meet deadlines with minimal supervision

INTERPERSONAL SKILLS:

- An ability to communicate effectively at all levels, orally and in writing
- A calm, tactful manner in dealing with all PCF Officers and where necessary external bodies
- The ability to work closely and effectively with other members of the team.
